

TERMS & CONDITIONS

OVERVIEW

This website is operated by Studifuel Limited (trading as Studifuel). Throughout the site, the terms “we”, “us” and “our” refer to Studifuel. Studifuel offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site and/ or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Terms of Service”, “Terms”), including those additional terms and conditions and policies referenced herein and/or available by hyperlink. Any payment information that you have changed may affect the payment, or it may be due to insufficient funds on the card you have registered for payment. We will retry payment every day for 10 days, after which if payment is still unsuccessful we will cancel your subscription and any pending shipments.

We aim to dispatch boxes within 2 days of receiving payment, however we cannot guarantee that this will always be the case and there may sometimes be delays in delivering some boxes.

If you wish to change your delivery address to a location which has a different delivery charge (e.g. from the UK to France and vice versa), we must be notified by email.

You must notify us within 7 days of receiving your box in order to be eligible for a refund. If your box has not arrived within the estimated delivery time, please let us know within 28 days of receiving your dispatch email in order to begin a refund or replacement process where applicable.

Photographs of the box may be requested. We review each request on an individual basis, and may ask you to return the box to us after photos have been received. Please ensure you obtain proof of postage when returning the box to us as we are unable to issue refunds if we do not receive the goods.
